Horizon Compact Selected to Deliver High Capacity Broadband Services in Burkina Faso

Ottawa, Canada, May 20, 2009 - DragonWave Inc. (TSX: DWI), the worlds' leading supplier of packet microwave radio systems, today announced that Connecteo is deploying the Horizon Compact to deliver high capacity broadband services to its enterprise customers in Burkina Faso.

Connecteo uses Horizon Compact to bypass traditional leased line infrastructure and provide cost efficient and scalable broadband IP services. Based in Dakar, Senegal, Connecteo has also established subsidiaries in Cameroon, Guinea, Bénin and Niger. The company is managed by Monaco Telecom, an affiliate in the international business unit of UK-based Cable & Wireless Group. Cable & Wireless operates integrated telecommunications companies in 33 countries worldwide, and Monaco Telecom manages those operations in Africa, Afghanistan and Kosovo.

Initial deployments in Burkina Faso provide up to 50 Mbps broadband access to Connecteos' enterprise customers with the option to scale to 400 Mbps over time. The Horizon Compact is perfectly suited to such access network applications. Physically it requires very little space and has low power consumption, characteristics that make it ideal for deployment in the enterprise. Also, because it is powered through the same Cat5 cable that delivers the broadband service it presents little disruption to in-building cable management and power systems. The Horizon Compact is mounted outdoors and has a proven track record for reliability and performance in some of the most challenging environments.

"Broadband access demand is very, very high, throughout Western Africa" said Rouylou Jean Michel, International Director Monaco Telecom. "Network costs have traditionally slowed progress in this market, but DragonWave's products are helping eliminate much of this burden and enable Connecteo to deliver higher speed broadband service to more and more customers."
